#### **NOTES**

Children are eligible for NEG funding the term after their 2<sup>nd</sup>, 3<sup>rd</sup> and 4<sup>th</sup> birthday. The Kindergarten applies for the funding on your behalf and the fees payable are calculated after deducting the funding. Parents entitled to the funding will need to update and validate the 11-digit code every 3 months and inform the Manager that it has been actioned. Failure to do this on time may result in funding not being paid by the government and the parents will be required to pay the difference.

\*For fully funded children the parents are required to make the following payments due to the shortfall of funding from the government:

Fully funded 15hrs- £75 per term Fully funded 30hrs- £150 per term

- ❖ A refundable deposit of £125 is payable on acceptance of an offer of a place at the Kindergarten. The deposit will be deducted from the last month's fees.
- Acceptance fee of £75 is payable on acceptance and this is non-refundable at any time.
- Fees are payable on the first day of the month/week by Direct Debit, vouchers or Cash. If you start midmonth, we will calculate pro-rata weekly fees for that month and thereafter the monthly or weekly fees will apply depending on parent's preference. Monthly/weekly fees include Bank holidays and training days.
- Those attending 45 weeks or Term Time, the yearly fees are calculated and apportioned over a period of 11 months taking into account all holidays (with no fees payable in August).
- We accept all Tax Free schemes, childcare vouchers including CGPS, Edenred, Care 4, Busy Bee, Sodexo, Kiddi vouchers and many others.
- Full uniform set including a book bag and a shoe bag is sold at the Kindergarten for £45.00 per pack. Extras can be bought separately.
- Healthy Meals Parents can bring a healthy meal in a lunch box.
- If you wish to have extra hours occasionally, the charges are £10.00 per hour for a child.
- Late Charges are applicable if a child is not collected on time and this is £1 per minute.
- Please note you will NOT BE entitled to a refund of any part of the fees if you take your child on holiday or the child is unwell.
- If your child is attending less than five days per week then it may not be possible to swap their days due to holiday or sickness as this will affect the adult child ratios.
- For fee paying children 1 month notice period is required otherwise fees will be charged in lieu of notice.
- Funded children will not be able to leave in between the term. A full terms notice period is required. It is the Kindergarten's policy that funding will not be transferred to another setting.
- Fees will be reviewed in August of each year in line with inflation, and one month's notice will be given by CKCNL.
